IMPORTANT INFORMATION-PLEASE READ THOROUGHLY

ALL GROOMING PETS MUST BE CURRENT ON DISTEMPER, RABIES, AND BORDETELLA (dogs only). IF YOUR PET HAS BEEN VACCINATED BY ANOTHER VETERINARIAN, WE NEED VERIFICATION OF VACCINATION AT THE TIME OF ADMISSION. **IF DOCUMENTATION IS NOT PROVIDED OR IF VACCINES ARE DUE DURING GROOMING, A PHYSICAL EXAMINATION WILL BE DONE PRIOR TO ADMINISTRATION OF ALL VACCINES.**

Please Note: All vaccinations must be given at least 72 hours before admission.

Please Note: If your pet has fleas, the groomer will administer flea control and the cost of the treatment will be added to your bill.

PLEASE NOTE: We love animals – but sometimes animals don't love being groomed. Even pets that are calm and well-behaved at home with their owners may become stressed at being left, being bathed, being clipped. Stressed animals can become aggressive. Please let our groomer know if certain procedures upset your pet so she can work with your pet to build confidence while maintaining a safe grooming environment.

If you **know** that your pet is potentially aggressive, it is your responsibility to notify our groomer before grooming takes place. Failure to notify the groomer that your pet may be aggressive or has already bitten others constitutes negligence and can result in legal action should the groomer be injured.

We reserve the right to refuse grooming services to animals that are known to be overly aggressive.

Please be aware we are required by state law to report to Animal Control any dog that bites any person or any other animal. Animals that bite may be placed in quarantine for at least 10 days at the owner's expense. (Ch 10, Article VI, Sec 10a). If your pet becomes aggressive during grooming, our groomer will stop the grooming session and will call and ask you to pick up your pet. You may be charged for services already provided.

Should there be a medical emergency during your pet's stay here, we will attempt to call you at the numbers listed above. In the event we are unable to contact you, emergency care will be provided at your cost.

As the owner or authorized agent of the pet identified above, I have read and understand this registration form and have asked questions as necessary. I also understand that my pet will not be groomed or boarded if:

1. I do not provide documentation of current vaccination.
2. My pet becomes aggressive.
3. The groomer identifies a medical condition (skin allergy, severely matted hair), which makes grooming unacceptable for my pet.
